A. Call To Order / Approval of the Agenda.

Approval Of The Agenda: It was moved and seconded to approve the agenda. The motion passed.

B. Discussion of Registered Dental Practitioner.

1. 2013 H.B. 2157. The Board received and reviewed 2013 H.B. 2157, which is proposed legislation that would add a new class of licensees called Registered Dental Practitioners (RDP) to the Kansas Dental Practices Act, K.S.A. 65-1421 *et seq.*

2. Minutes of January 20, 2012. The Board received and reviewed its minutes from the Board meeting of January 20, 2012. The minutes include the Board's previous position on an RDP proposal found in 2011 H.B. 2280 and 2011 S.B. 192.

At the request of Glenn Hemberger, D.D.S., President, each Board Member identified and discussed various points of interest, question, or concern with the proposed legislation, 2013 H.B. 2157. After extended discussion from each Board member and the Board collectively, it

was moved and seconded to oppose 2013 H.B. 2157 as written. Upon a roll call vote, the motion passed unanimously. The Board unanimously opposed 2013 H.B. 2157 as written.

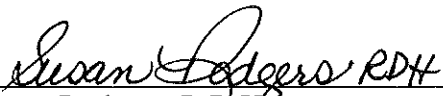
C. New Business / Adjournment.

With Dr. Stasch's approval, Lane Hemsley will notify UMKC that the ECP III training course has received the requisite Board approval necessary for final implementation.
