**A. Call to Order / Approval of the Agenda.**

**B. Minutes of January 16, 2015, and Minutes of February 18, 2015.**

**C. North Carolina State Board of Dental Examiners v. Federal Trade Commission.**

Attorney Randy Forbes presented an overview of United States Supreme Court's decision in *North Carolina State Board of Dental Examiners v. Federal Trade Commission*. Mr. Forbes discussed the decision in light of Kansas Attorney General Opinion 08-13, K.A.R. 71-11-1, and *Kansas Dental Board v. One Hour Smile*, Shawnee County District Court Case No. 10-C-1835. After extended discussion regarding the informational agenda item, the Board took no action.

**D. Board Participation in Regional Clinical Exams.**

The Board welcomed former member, Roger Stevens, D.D.S. Dr. Stevens discussed the merits of continued Board participation and involvement in the regional clinical exams, including, but not limited to, CRDTS and WREB. Dr. Stevens further encouraged the Board to contemplate review of examination materials, such as candidate manuals and written exam topics, every couple of years. Dr. Stevens also asked the Board to begin the process of identifying a current Board member who could replace him during representative activities for the regional clinical exams and national dental groups, such as the American Association of Dental Boards (AADB).

**F. Stipulation and Consent Orders.**

Jeff Stash, D.D.S., contacted the bordering states of Kansas and Texas to find out laws regarding the unlicensed practice of dentistry. After extended discussion, the Board requested that staff investigate the possibility of preparing a public service announcement for local radio and television for the areas of Kansas that are most affected by the unlicensed practice of dentistry.

1. **Budget.** An update was provided on the budget for FY 2015 (July 1, 2014 – June 30, 2015).

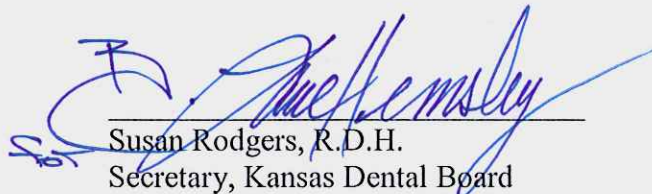
2. **Licensee and Specialty Licensee Report.** License and specialty license reports from January 1, 2015, to March 15, 2015, were presented to the Board.

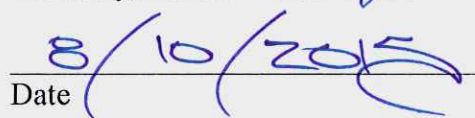
**J. New Business / Adjournment.**
