## Board Approves ECP III Course Developed At UMKC

At its regularly scheduled public meeting on Friday, January 18, 2013, the Board welcomed Becky M. Smith, D.D.S., and Bonnie Branson, R.D.H., Ph.D., of UMKC School of Dentistry (UMKC). With the collaboration of the Kansas Department of Health and Environment, Bureau of Oral Health, UMKC has developed a training course for the Extended Care Permit III (ECP III) under K.S.A. 2012 Supp. 65-1456.

The training course is offered as an online course and will conclude with a

practical lab component and competency exam held on-site at UMKC. The online components include use of an electronic blackboard with various learning modules, including review of the ECP III law, atraumatic restorative techniques, temporary restoration placement, denture adjustments and soft relines, extraction of mobile primary teeth, and pharmacological agents.

The online course also implements the use of online instructional

videos for the various learning modules. The first course will open for online study in or around March 2013 and a practical lab component and competency exam will be held at UMKC in or around July 2013. After review, the Board unanimously approved the ECP III training course.

## Board Opposed To Proposed RDP Legislation

On Friday, February 15, 2013, the Board held a special meeting to receive and review 2013 House Bill 2157, which is proposed legislation that would add a new class of licensees called registered dental practitioners (RDP) to the Kansas Dental Practices Act (Act). Currently, the Act only grants the

Board the legal authority to issue licenses for dentists and registered dental hygienists. Additionally, the Board has the legal authority to issue sedation permits to dentists and extended care permits to registered dental hygienists. Last year, the legislature granted the Board

the authority to issue an Extended Care Permit III (ECP III). The ECP III approval process is well underway.

After extended discussion regarding the proposal, the Board decided to oppose 2013 House Bill 2157 as written.

## Dental Professionals Urged To Control Your Controlled Substances

The Board's Investigative Committee continues to see an increasing number of complaints alleging the excessive and improper prescribing of controlled substances and the failure to secure controlled substances within the dental office. The abuse and non-medical use of prescription drugs, quite often opioid pain kill-

ers, continues to increase at an alarming rate.

Generally, the core standard is that a controlled substance may only be prescribed, administered, or dispensed for a legitimate purpose by a practitioner acting in the usual course of professional practice. The role of a dentist, dental hygienist, and den-

tal office team with controlled substances remains critical to patients' health and safeguarding society against the diversion of controlled substances.

At its regularly scheduled public meeting held in Topeka on Friday, January 18, 2013, the Board welcomed its newest dentist member, Jeff Stasch, D.D.S. Appointed by Governor Brownback to succeed Michael Milford, D.D.S., as a dentist member of the Board for the First Congressional District, Dr. Stasch will serve a 4-year term. Under the Kansas Dental Practices Act, Board members serve 4-year terms up to a maximum of two terms. Dr. Stasch looks forward to his Board term.

## Continuing Education Audits

The continuing education requirements are found in K.A.R. 71-4-1 and K.A.R. 71-4-2. Each year, some licensees are chosen at random by computer to submit continuing education proof. On occasion, some of those randomly chosen for audit are unable to provide proof of continuing education certificates. Failure to properly report continuing education hours or failure of an audit could result in disciplinary action.



## Board Members Volunteer At KMOM

On March 1 - 2, 2013, the Kansas Dental Charitable Foundation held the Kansas Mission of Mercy dental clinic (KMOM), at the Kansas Coliseum Pavilion II building in Wichita, Kansas. According to the Kansas Dental Charitable Foundation, led by Executive Director Greg Hill, the first day of the event resulted in the treatment of 828 patients with \$814,434 in free dental care. More than 1,100 volunteers, including about 150 dentists, 150 dental hygienists, and 175 dental assistants, from the community helped provide services.

Co-founder of the event and the Board's newest member, Jeff Stasch, D.D.S., called the tenth year of KMOM a "continued opportunity to provide good quality dental care to communities across the state." Board Members Glenn Hemberger, D.D.S., Jeff Stasch, D.D.S., and Susan Rodgers, R.D.H., provided dental services to patients treated at the KMOM event.

Dodge City is the site for the 2014 KMOM. The event will be held from February 28—March 1, 2014, at the Dodge City Western State Bank Expo Center. 
