**APPROVAL OF CONTINUING EDUCATION COURSE**

**K.A.R. 71-4-2. (a) Eligibility.** Only those courses **which increase the dentist's or dental hygienist's clinical and theoretical dental knowledge or ability to provide care and treatment to patients** shall qualify for credit in computing the required hours of continuing dental education.

A certificate of completion will need to be provided to participants at the end of this presentation. The certificate should contain: Course title, date, clinician, sponsor, participant's name, hours approved, and the Kansas Dental Board number that will be given in the approval letter for CE.
