FINAL AGENCY ORDER

On February 1, 2008, the Kansas Dental Board (the "Board") held a hearing on the Application of Robert B. Colt ("Colt") for a license to practice dentistry in the State of Kansas. Colt appeared in person and through counsel, Steven Michalek, 1050 17th Street, Denver, Colorado 80265-2080. Randall J. Forbes of Frieden & Forbes acted as the Board's counsel. After considering the evidence admitted at the hearing, the Board enters the following final agency order.

I. FINDINGS OF FACT

1. On June 22, 2007, the Board received an application from Colt requesting a Kansas license to practice dentistry by credentials from Colorado.
2. On January 29, 2008, the Board issued a Summary Order of Denial, whereby Colt's application to practice dentistry in Kansas was denied.

II. CONCLUSIONS OF LAW AND FACT

3. Colt's application to practice dentistry in the State of Kansas should be approved, subject to the following restrictions:
 - a. Colt's license to practice dentistry shall be placed on probation for a period of one (1) year, which shall commence on February 1, 2008 ("the license probation period");
 - b. During the license probation period, Colt shall permit an agent of the Board to perform a review of his records to ascertain the adequacy of his diagnosis and treatment planning

and to determine whether he is performing dental treatments with adequate treatment plans to substantiate the dental treatments. The review of Colt's records shall be performed at the 6 and 11 month intervals of the license probation period. If the record review reveals that Colt is performing dental treatments with inadequate treatment plans to substantiate the dental treatments, the Board may initiate a non-emergency proceeding to revoke, suspend, or otherwise limit Colt's license to practice dentistry; and

c. Colt shall provide the Board, within thirty (30) days from the effective date of this Final Agency Order, with evidence of completion of the continuing education hours in the areas of risk management and treatment planning that he reported to the Board. If Colt fails to provide the Board with evidence of completion of the continuing education hours, the Board may initiate a non-emergency proceeding to revoke, suspend, or otherwise limit Colt's license to practice dentistry.

5. If Colt has successfully complied with the above-referenced restrictions at the end of the license probation period, the license probation period shall cease.

III. FINAL ORDER

Based upon the evidence introduced at the hearing held February 1, 2008 and the foregoing findings and conclusions, Colt's application for a license to practice dentistry in the State of Kansas is hereby granted. Colt's license to practice dentistry shall be designated as License No. 60537.


Within fifteen (15) days after service of this Final Agency Order, either party may file a petition for reconsideration pursuant to K.S.A. 77-529.

Within the time limits established in K.S.A. 77-613, either party may seek judicial review of this Final Agency Order, pursuant to said statute. The agency officer designated to receive service of a petition for judicial review is:


