STIPULATION AND CONSENT ORDER

IT IS HEREBY STIPULATED AND AGREED by and between the Kansas Dental Board (the "Board") and Svetlana Sobolevskaya, D.D.S. (the "Respondent") as follows:

- 1. The Board is represented herein by its attorneys, Randall J. Forbes and Brenda L. Head of Frieden & Forbes, 1414 SW Ashworth Place, Suite 201, Topeka, Kansas 66604. The Respondent is represented herein by her attorney, Richard T. Merker of Wallace Saunders, 10111 West 87th St., Overland Park, Kansas 66212.
- 2. The Board is the Kansas agency vested with the authority, pursuant to K.S.A. 74-1404 and K.S.A. 74-1406, to carry out and enforce the provisions of the Kansas Dental Law, K.S.A. 65-1401 *et seq.*, including conducting hearings and proceedings to revoke, suspend or otherwise discipline a Kansas license to practice dentistry.
- 3. The Respondent is presently entitled to engage in the practice of dentistry in the State of Kansas by reason of the Board having issued her Kansas license number 60200. At all times relevant hereto, the Respondent has held a current license to engage in the practice of dentistry in the State of Kansas.
- 4. The Board has received certain information, has investigated and has determined that there are reasonable grounds to believe that the Respondent has committed an act or acts in violation of the Kansas Dental Act, K.S.A. 65-1401 *et seq*.

5. Respondent hereby admits and waives any further proof in this or any other proceeding before or initiated by the Board, and upon motion duly made, seconded and passed, the Board finds, that:

A. On or about November 14, 2016, the Board received notice from the National Practitioner Data Bank ("NPDB") that a September 19, 2016 medical malpractice payment of \$150,000.00 was made on behalf of licensee for allegations of failure to diagnose atypical ameloblastoma in the right jaw of Patient KB on or about December 8, 2007, indicating that Licensee has engaged in a number of practices that may violate the Kansas Dental Act.

B. The report and the subsequent investigation by the Board established that Respondent from approximately December 8, 2007 through May 10, 2013, failed to include a full mouth x-ray series or panoramic view x-ray for Patient KB in her care and treatment, although Respondent diagnosed a chronic periodontal condition with the patient.

C. On May 11, 2013, a periapical x-ray of KB was taken revealing large radiolucency and after a panoramic x-ray was taken, Respondent referred KB to an oral surgeon for treatment which resulted in a diagnosis of atypical ameloblastoma in the right jaw.

D. Respondent's medical records for Patient KB fail to include treatment plans which include recommended x-rays and they fail to contain patient refusals of any recommended treatment.

Upon motion duly made, seconded and passed, the Board finds that Licensee's conduct violates the Kansas Dental Act and subjects her license to discipline pursuant to K.S.A. 65-1436(a)(17) and K.S.A. 65-1436(a)(3) as defined at K.S.A. 65-1436(c)(2).

6. The Respondent agrees and consents, and the Board finds and concludes, that the following disposition is just and appropriate under the circumstances:

- A. ADMINISTRATIVE FINE. Respondent agrees, and the Board further orders the Respondent to pay to the Board, within ten (10) days of the effective date of this Stipulation and Consent Order, an administrative fine of Five Thousand Dollars (\$5,000).
- B. OTHER REQUIREMENTS. Respondent acknowledges and agrees that as a condition of this Stipulation and Consent Order she must, and the Board further orders the Respondent to:
 - 1. Comply fully with this Stipulation and Consent Order; and
- 2. Comply fully with the Kansas Dental Act, the Board's rules and regulations and all state and federal laws relating to Kansas dentists.
- 7. Respondent agrees that all information in the possession of the Board's Investigation Member, its staff, its investigators and its attorney regarding the notice which led to this disciplinary action, the investigation of the complaint and all information discovered during the pendency of the disciplinary action may be disclosed to and considered by the Board as part of the presentation and consideration of the proposal of settlement in the form of this Stipulation and Consent Order, with or without the presence of the Respondent or her attorney. In the event that this Stipulation and Consent Order is not accepted and approved by the Board, the Respondent further waives any objection to the Board members' consideration of this Stipulation and Consent Order or the information mentioned in the preceding sentence and further agrees to waive any claim of due process violation or the right to seek the disqualification of any Board member as a result of the Board member's consideration of said document and information.
- 8. The stipulations and orders contained herein shall not become binding until this Stipulation and Consent Order is approved and entered by the Board. The Respondent

acknowledges that the approval of the Board's attorney shall not constitute the approval of the Board or bind the Board to approve this Stipulation and Consent Order.

9. The Respondent agrees that this Stipulation and Consent Order is in conformance with Kansas and federal law and the Board has jurisdiction to enter into it. The Respondent further agrees that the Kansas Dental Act, K.S.A. 65-1421 *et seq.*, is constitutional on its face and as applied in this case.

10. This stipulation constitutes the entire agreement of the parties and may only be modified by a subsequent writing signed by them. The agreement shall be interpreted in accordance with the laws of the State of Kansas.

11. The Respondent acknowledges that she has the following rights:

A. To have formal notice of charges served upon her:

B. To file a response to the charges;

C. To have notice of and participate in a formal adjudicative hearing with the Board making specific findings of facts and conclusions of law based only upon evidence admitted at such hearing; and

D. To take advantage of all applicable provisions of the Kansas Administrative Procedures Act and the Act for Judicial Review and Civil Enforcement of Agency Action.

The Respondent freely waives these rights and acknowledges that said waiver is made voluntarily and in consideration of the Board's limiting the disciplinary action taken against her to those provided for herein. The Respondent further waives the right to seek reconsideration or appeal or otherwise contest this Stipulation and Consent Order.

12. The Respondent acknowledges that she enters into this Stipulation and Consent

Order freely and voluntarily after consultation with counsel of her choosing. The Respondent

further acknowledges that she has read this Stipulation and Consent Order in its entirety, that she

understands its legal consequences and that she agrees that none of its terms are unconscionable,

arbitrary or capricious.

13. Time is of the essence to this Stipulation and Consent Order. Respondent

acknowledges and agrees that any violation of this Stipulation and Consent Order shall constitute

a willful violation of a lawful Board order and grounds for further disciplinary action against her.

The pendency of any disciplinary action arising out of an alleged violation of this Stipulation and

Consent Order shall not affect the obligation of Respondent to comply with all terms and

conditions of this Stipulation and Consent Order.

14. This Stipulation and Consent Order constitutes the entire and final agreement of

the parties. In the event any provision of this Stipulation and Consent Order is deemed invalid or

unenforceable by a court of competent jurisdiction, it shall be severed and the remaining

provisions of this Stipulation and Consent Order shall be given full force and effect.

15. Upon execution by all parties and entry as an order by the Board, this Stipulation

and Consent Order shall be a public record in the custody of the Board.

16. This Stipulation and Consent Order shall become effective on the day it is

approved, accepted and made an order of the Board by way of signature of the Board's President

or the President's authorized representative.

17. The Respondent acknowledges that she has been advised by the Board that she

would have the right within 15 days after service of this Stipulation and Consent Order to file a

petition for reconsideration with the Board and the right within 30 days after service of the

Stipulation and Consent Order to file a petition for judicial review in the District Court of Shawnee County, Kansas in accordance with the Kansas Act for Judicial Review and Civil Enforcement of Agency Actions, K.S.A. 77-601 et seq., and to serve such a petition for judicial review on the Kansas Dental Board by serving B. Lane Hemsley, its Executive Director, at 900 SW Jackson, Room 564-S, Topeka, KS 66612. The Respondent hereby waives those rights.
