DENTAL AND DENTAL HYGIENE APPLICATION BY CREDENTIAL

PHASE ONE – FULLY COMPLETED APPLICATION PACKET:

1. Fully Completed Application Packet.

An application that is missing the application fee, incomplete in any way, or folded will not be processed and returned as incomplete.

A dental applicant may apply by credential if the applicant holds a license to practice dentistry in one or more states and has been in the active practice of dentistry during the five (5) years immediately preceding the date of the application.

A dental hygiene applicant may apply by credential if the applicant holds a license to practice dental hygiene in one or more states and has been in the active practice of dental hygiene during the three (3) years immediately preceding the date of the application.

2. Application Fee.

Dentist: \$300
Hygienist: \$300

The non-refundable fee is payable by check or money order to the Kansas Dental Board. Credit card, cash, or e-payments are not accepted. There are two fees. This is the first fee. All fees are waived for active military and spouse only with a copy of military orders.

3. Delivery Method.

The application must be fully completed and printed on standard letter paper size, which is 8.5 x 11 inches. Do not fold the application. Enclose the application in an envelope large enough to avoid folding. The Board will not confirm whether an application has been delivered. If you need delivery confirmation, use FedEx, UPS, or certified USPS mail.

4. Photograph.

A current photograph, wallet or passport size, shall be securely attached to the application in the space provided with tape or glue only. No staples or paperclips are permitted. The photograph must include the applicant's image only. No pets or loved ones are permitted.

5. Notary Public.

The original application must be completed, signed, and notarized in the presence of a notary public after the photograph is attached and prior to delivery to the Board office.

6. National Board Exam Scores (Copy).

The national board exam results are available online. The results must clearly show the applicant's name, DENTPIN number, and successful exam outcome. A copy of the national board scores must be enclosed in the original application packet.

7. Clinical Board Exam Scores (Copy).

The Board accepts CRDTS, SRTA, CDCA, NERB, WREB, CITA, ADEX, and State Board clinical scores. The results must clearly show the applicant's name and a passing score. A copy of the clinical board scores must be enclosed in the original application packet.

8. CPR Card (Copy).

The copy should be provided on standard letter paper size, which is 8.5 x 11 inches. A copy of the CPR card must be enclosed in the original application packet.

9. Verification of All State Licenses (Original).

A verification of each state license from each state licensing agency must be enclosed in the original application packet. The verification must have a raised seal and be enclosed in a sealed envelope. If a state's online verification serves a "Primary Source" verification, a printed copy from the website may be submitted. A copy of the state license is not an official verification.

10. National Practitioner Databank Self-Query.

A self-query from the National Practitioner Databank (NPDB) must be enclosed in the original application packet. General instructions are as follows:

- www.npdb.hrsa.gov
- For Health Care Professionals
- Place a Self-Query Order
- Start a new order
- Accept the terms > Submit and Continue
- Which type of NPDB search do you need? > Personal
- Start with subject information and continue with all steps required
- Pay the applicable fee
- Print the report and enclose it in the original application packet

11. Supplemental Documentation.

a. Recommendation Letter – Dentist Only.

One recommendation letter from a licensed dentist in any state. The letter must be presented on letterhead with an original signature. It does not need to be in a sealed envelope.

b. Local Anesthesia and Nitrous Oxide Certificates – Hygienist Only.

A copy of each certificate may be submitted. Do not send originals.

12. Original Transcript – ADA Commission on Dental Accreditation (CODA) Educational Program.

Each applicant must have graduated from a CODA educational program in the United States, Canada, or Puerto Rico. A transcript with degree awarded in an unopened, sealed envelope may be included in the original application packet. A transcript with degree awarded may also be sent directly to the Board office from the Registrar's office in hard copy or via e-transcript to dental.info@ks.gov.

13. Continuing Education Certificates (Copy).

Each applicant must attach proof of continuing education hours taken within the last two (2) years. Proof of continuing education hours requires copies of the certificates of each course completed. Dental applicants are required to provide sixty (60) hours. Dental hygiene applicants are required to provide thirty (30) hours.

PHASE TWO – JP EXAM AND LICENSING:

1. Jurisprudence Exam (JP Exam).

The JP Exam is based on the Kansas Dental Practices Act, which is found at no cost under the "Laws" link on the Board's website. The JP Exam is open book, open laptop, or open tablet, but not open phone.

An application with payment must be received prior to scheduling the exam. You will be notified by e-mail to schedule the exam. The exam may be taken at a dental or dental hygiene school, educational institution, testing center, or local library. The exam must be proctored for 90 minutes. Each applicant must make their own arrangements. Contact the facility and arrange from a date and time at least a week prior to the exam. E-mail your JP Exam location, date, proctor's name, and proctor's e-mail to dental.info@ks.gov. The documents and instructions will be e-mailed to the proctor.

2. Prorated License Fee.

The fee is determined at the time of licensure. You will be notified by e-mail when your application is complete. The non-refundable fee is payable by check or money order to the Kansas Dental Board. Credit card, cash, or e-payments are not accepted. There are two fees. This is the second fee. All fees are waived for active military and spouse only with a copy of military orders. The Board will not confirm whether a fee has been delivered. If you need delivery confirmation, use FedEx, UPS, or certified USPS mail.
