ORDER OF COMPLETION

The Kansas Dental Board ("Board") issued a Stipulation and Consent Order on October 14, 2011 ("Consent Order"). Under the Consent Order, Stephen W. Jones, D.D.S. ("Respondent") was required to pay an administrative fine of Two Thousand Dollars (\$2,000.00) within ten (10) days of the effective date of the Consent Order and attend a continuing education course sponsored by the ADA in Chicago, Part One (4 hours online) and Part Two (5 hours hands on workshop) – "Recognition and Management of Complications During Minimal and Moderate Sedation." The Respondent timely paid the administrative fine and completed the continuing education course, "Recognition and Management of Complications During Minimal and Moderate Sedation."

After completion of the continuing education course, the Respondent's sedation permit was restricted in that he must restrict his sedations to perform sedation on one patient who is being prepared for treatment plus one recovering from treatment. On November 6, 2014, the Respondent faxed a signed letter to the Board stating that he would not be renewing his sedation permit and no longer be practicing sedation dentistry. The Respondent voluntarily relinquished his sedation permit to the Board on November 6, 2014. The Respondent has completed all requirements of the Consent Order dated October 14, 2011, and the case has been closed.

If, in the future, the Respondent should ever apply for any Kansas sedation permit and the Board were to determine that the then-existing circumstances warranted granting the application, which it is not obligated by these provisions to do, the above-referenced case will immediately

be reopened and the Consent Order dated October 14, 2011, will immediately go back in effect. Accordingly, any sedation permit the Respondent may receive in the future will have the restriction in that he must restrict his sedations to perform sedation on one patient who is being prepared for treatment plus one recovering from treatment. The restriction would remain until further order of the Board.
